Countless reports of energy anomalies motivate us to explore the thermodynamics of open systems to answer:

- · Which ones actually work,
- How well do they perform,
- · Where, does energy gain/loss occur, and
- Which theory of energy gain/loss best fits experimental observation?

This in mind, we examine some FE/OU devices to show how Open Systems Thermodynamics clarifies the system's operation and compare theories of energy release. These would include:

- Paul Pantone's GEET Energy from the vacuum, or from the local environment?
- Josef Papp's piston engine Electromagnetic, nuclear, or something else?
- **Pulsed EMF Motors** Non-linear electromagnetics, or extraction from ZPE?

The science of thermodynamics was developed to make sense of energy's quantity, direction, and rate of flow. For heat engines doing mechanical work, postulating strict conservation of mass and energy worked beautifully. Conversely, the Big Bang theory seems to contradict mass-energy conservation, so why should we assume that mass-energy conservation is universal law?



The Physics of FREE Energy / Overunity Transformers

A typical AC transformer utilizes a principle of transferring electrical energy called *mutual electromagnetic induction*. This effect described as Faraday's Law of Induction (1831) permits a near equal amount of REAL power to be transferred between the input coil and the output coil. The "near equal amount" is the result of imperfections or losses in the transformer causing the efficiency of the same transformer to approach, but never exceed 100%.

In the 1980s, Floyd Sweet developed a transformer he called the Space Quanta Modulator (SQM) and later renamed the Vacuum Triode Amplifier (VTA) by Tom Bearden. The transformer had an efficiency exceeding 1,000,000%. Mainstream physics could not explain how this was possible. Shrouded in secrecy, the operation of Floyd's VTA device was not understood until now.



In 2002, an article published in *Infinite Energy Magazine* by D.L. Hotson revealed how the VTA operates utilizing what is called the "Dirac Sea of Negative Energy." The key to understanding how FREE Energy / Overunity transformers work is through the application of a negative work function applied to transformer T1 shown above.

This negative work function is created using magnets forced together in an opposing field configuration. This electromagnetic dampening field is present around transformer T1. Since the output power of transformer T1 drives a REAL load, the output electric current is REAL. Therefore, efficiencies greatly exceeding 100% are measured.
